Dear Honorable Judges, Attorneys, and Citizens of the Commonwealth of Pennsylvania serving on the Judicial Conduct Review Board of PA:

My name is Franklin D. Shaffer. I was born in Morgantown, WV, on June 28, 1961.

I'm an engineer. I am not an attorney. I have no formal legal training. The following sections describe my relevant background as a federal employee and as a civil rights activist in Pittsburgh for 30 years.

MY RELEVANT BACKGROUND AS A FEDERAL EMPLOYEE

I was a federal employee with the US Department of Energy for thirty-two years. I was stationed at the Pittsburgh site of the US Department of Energy's National Energy Technology Laboratory (NETL). I have a website about my background, my federal service with the US Department of Energy, and as a civil rights activist in Pittsburgh for 30 years: <http://FDShaffer.net> If you are reading from a printed document and cannot follow web links in this report, my website and the http links in this document are easily found by a simple web search.

I owned a house at 2786 Tischler Road, Bethel Park, 15102. The Magistrate Court of Ronald Arnoni is located at 2414 Lytle Road in Bethel Park, which is ¼ mile from my house.

MY RELEVANT FEDERAL SERVICE ON THE LEAD TEAM RESPONDING TO THE DEEPWATER HORIZON OIL LEAK CRISIS

I was on the lead team responding to the Deepwater Horizon oil leak crisis: *The Plume Team of the Flow Rate Technical Group of the National Incident Command*. Coast Guard Admiral Thad W. Allen was the National Incident Commander of the Unified Command for the Deepwater Horizon oil leak crisis. 

Our team was led by Dr. Marcia McNutt. At that time, she was the first woman to serve as the Director of the US Geological Survey since it was founded in 1879. The USGS maps and studies the landscape of the United States, our natural resources, and *the natural hazards that threaten it*. The USGS also makes maps of extraterrestrial planets and moons based on data from U.S. space probes.

Dr. McNutt is now the first woman to serve as the President of the National Academy of Sciences (NAS). The NAS was founded by Abraham Lincoln in 1863 to serve as pro bono "Advisors to the Nation" on all scientific matters. The NAS holds a congressional charter under Title 36, Chapter 1503, of the United States Code. Below is a letter I received from Marcia:

The Deepwater Horizon oil leak, which was caused by British Petroleum, was the most dangerous environmental threat to our country since we declared independence from the British in 1776.

I played an important role in stopping the damage being done to 1000 miles of US shoreline of five Gulf states. I then, with Dr. McNutt, co-authored the definitive peer reviewed journal paper reporting how much crude oil was discharged into the Gulf of Mexico by British Petroleum: *Review of the Flow Rate Estimates of the Deepwater Horizon*. We published our paper in the Proceedings of the National Academy of Sciences. It, along with my other peer reviewed journal publications with UC Berkeley, are the basis for the \$20.8 billion fine. It is the largest single fine of a single entity in US history. Those funds went to the fifty million people of five Gulf states to recover and rebuild.

The \$20.8 billion fine was ordered on October 5, 2015, by the Honorable US District Court Judge Carl J. Barbier for the Eastern District of Louisiana. I was immediately attacked in retaliation. The reason that I am being attacked and the other members of the Plume Team are not being attacked, is that I'm also a civil rights activist. I was active in Pittsburgh for 30 years.



MY BACKGROUND AS A CIVIL RIGHTS ACTIVIST IN PITTSBURGH

I am also a civil rights activist. I was active in Pittsburgh for thirty years. I worked for social justice and civil rights in Pittsburgh and at the USDOE National Energy Technology Laboratory (NETL). The people who attacked me after the \$20.8 billion fine was ordered were all subjects of my peaceful protests and lawsuits (e.g., People Against Police Violence v. City of Pittsburgh, the Honorable US District Court Judge Joy Flowers Conti for the Western District of PA, presiding), while I was a board member of the Thomas Merton Center in Pittsburgh. Before I proceed, let me make it clear that I and my family have always supported law enforcement and police officers. I am from a small town, Keyser, in West Virginia. My family worked closely with Congressman Harley O. Staggers Sr (former Chair of the House Committee on Energy and Commerce) and Attorney Congressman Harley O. Staggers Jr. Harley O. Staggers Sr once served as the Sheriff of Mineral County WV. Keyser is the county seat of Mineral County.

Attorney Congressman Harley O. Staggers Jr was a member of the House Judiciary Committee from 1983 to 1993. My father, Reverend Dr. Dallas B. Shaffer, was his campaign manager and senior advisor on how the House Judiciary Committee should interact with the Supreme Court.

My father helped write the early versions of the Violence Against Women Act (VAWA). The Violence Against Women Act (VAWA) is a United States federal law (Title IV of the Violent Crime Control and Law Enforcement Act, H.R. 3355). The VAWA Act provided \$1.6 billion (\$3.5 billion in 2025 dollars) in funding for law enforcement throughout the United States for the investigation and the prosecution of violent crimes against women. It imposed automatic and

mandatory restitution on those convicted, and allowed civil redress when prosecutors chose not to prosecute cases. The Violence Against Women Act is still in effect today.


MY BACKGROUND WITH THE MAGISTRATE OF BETHEL PARK RONALD ARNONI

One of the reasons I got involved with the Thomas Merton Center in Pittsburgh in 1999 was that I, and the people of Pittsburgh, were informed by the news media of the murder of an innocent African-American businessman Jonny Gammage. Jonny Gammage was born in Syracuse, N.Y. on July 20, 1964. He graduated in 1987 from the State University of New York at Buffalo. Gammage was the business partner and adviser for his cousin, NFL Steelers player Ray Seals. Gammage was helping Seals manage his entrepreneurial and philanthropic ventures. Seal's father was Syracuse police officer Tommy Seals.

On Thursday, October 12, 1995, at 2AM, Jonny Gammage was driving a new Jaguar XJ6 owned by his cousin, Pittsburgh Steelers player Ray Seals, through Brentwood, a suburb of Pittsburgh. Two Brentwood police officers working for the Council member and Mayor of Brentwood Ronald Arnoni were involved in the murder of Jonny Gammage – with impunity. None were not held accountable, by mistrial or acquittal.

Although no one was held accountable for the murder of Jonny Gammage, the case was a factor in the US Department of Justice Office of Civil Rights forcing the City of Pittsburgh to sign the first Consent Decree order against a city in the United States. The Consent Decree was signed by the City Solicitor of Pittsburgh Jacqueline Morrow and the Assistant City Solicitor of Pittsburgh *Susan E. Malie*.  3. Failure to Discipline Officers Adequately
 4. Failure to Supervise Officers

ON THE RECKLESS RELEASE OF STATE SECRETS ABOUT THE PROLIFERATION, PROPOSED USE, AND ACTUAL USE OF NUCLEAR WEAPONS BY MAGISTRATE RONALD ARNONI

Another reason that I got involved with the Thomas Merton Center in 1999 is that I'd watched Pakistan and India nearly get into a nuclear war. As an engineer with the US Department of Energy, I was privy to state secret level information about the proliferation, proposed use, and actual use of nuclear weapons. The USDOE develops and manages the United States' nuclear weapons stockpile.

On May 11 and May 13 of 1998, India detonated five nuclear weapons. It was only the second time India had detonated a nuclear weapon.

The first detonation by India was fifty years ago, on May 18, 1974, a festival day celebrating the birth of Gautama Buddha. The detonation was code-named as "Smiling Buddha."


In 1998, India detonated five nuclear weapons. India code-named the detonations as "Operation Pokhran-II Shakti" and the nuclear weapons were designated as Shakti-I through Shakti-V. The first was a high-yield fusion weapon and the remaining four were fission weapons.

On May 28, 1998, seventeen days after India's Operation Pokhran-II Shakti, Pakistan answered by blowing up mountains in the Chagai Hills and the Ras Koh Hills of Pakistan with five nuclear weapons. Pakistan named this "Operation Chagai-I." On May 30, 1998, Pakistan detonated another nuclear weapon for observation by the Prime Minister of Pakistan Muhammed Nawaz Sharif, A.Q. Khan, and nuclear scientists from the United States. A.Q. Khan, with secret help from the USDOE Los Alamos National Laboratory, led the development of Pakistan's nuclear weapons program.


The Atomic Vapor Laser Isotope Separation (AVLIS) Process used by Pakistan to develop their own nuclear weapons stockpile was secretly provided by the United States. I am an eyewitness to this. I had silently kept this secret safe for 28 years. This state-secret level information was recklessly released into the public domain when common pleas Judge Hugh F. McGough and Allegheny County Solicitor Luke C. Kelly stole my RV under color of law, and then when, on January 18, 2019, Magistrate Ronald Arnoni had a police SWAT team raid my house without cause and throw me out. I had hard drives with labels stating "Property of US Government"

both in my house and in my RV. That night I fled into Amish country Ohio to escape and try to hide.

MY BACKGROUND IN ORGANIZING PEACEFUL PROTESTS AND LAWSUITS AGAINST MAGISTRATE RONALD ARNONI

Regarding the murder of Jonny Gammage: Brentwood Police Officers pulled Gammage over just within the Pittsburgh city limits along State Route 51. They began following Gammage, who was driving his cousin's new Jaguar XJ6 through Brentwood on Saw Mill Run Boulevard (Route 51).


Gammage was not violating any traffic regulations. He was committing no crimes. He was not intoxicated. He had no weapons. He was simply "DWB" in a Jaguar luxury car through Arnoni's Brentwood.



The murder of George Floyd by "positional asphyxiation"

Baldwin Township Officers and Brentwood Police Officers working for Arnoni murdered Jonny Gammage in the same way George Floyd was murdered 25 years later – by *positional asphyxiation* – in other words, suffocation by prolonged compression of his chest and neck. But in 1995 there were no cell phones with cameras to record the murder of Jonny Gammage.

The official autopsy and an additional autopsy by Dr. Cyril Wecht found that Gammage died of positional asphyxiation.



The murder of Jonny Gammage was a factor leading to the first Consent Decree between a US city and the US Department of Justice. The DOJ had to threaten in US District Court to take over the Pittsburgh Police Department to force the City of Pittsburgh to agree to the Consent Decree. The Consent Decree was signed by the City Solicitor of Pittsburgh Jacqueline Morrow and the Assistant City Solicitor of Pittsburgh *Susan E. THE ATTACKS ON ME BY MAGISTRATE RONALD ARNONI

ATTACK 1: THE FIRST RAID ON MY HOUSE BY OFFICERS WORKING FOR RONALD ARNONI.

On January 8, 2016, two months after the \$20.8 billion fine was ordered on October 5, 2015, Magistrate Ronald Arnoni had three Bethel Park Police Officers enter my home at 2786 Tischler Road, Bethel Park, PA, 15102. They didn't knock on my front door. When I encountered them, they were standing in my living room.

Arnoni's Police Officers ordered me out of my home and ordered me not to return. Magistrate Arnoni and his officers then opened Docket FD-16-00031 in Allegheny County Court records. They then began filling FD-16-00031 with defamatory, inflammatory lies about me, including the despicable lie that I assaulted my wife and her autistic daughter. I was not arrested or charged with anything because I'd done nothing wrong.

I do not assault anyone -- let alone helpless little autistic girls. Instead, I got her a puppy. I got her a "cool" ZED house to help her make friends. I got her into one of the best school systems in Pennsylvania. This is the little girl that those despicable cowards created false records about, giving the false impression that I assaulted:



A month later, on February 8, 2016, Magistrate Arnoni promoted all three of the Officers who threw me out of my home and fabricated false records about me -- to Sergeants. The photo below is from the February issue of The Almanac (<https://www.thealmanac.net>) which provides news coverage for the south of Pittsburgh. I added the text boxes.

ATTACK 2: DESECRATION OF MY FATHER'S FUNERAL On February 24, 2016, one hundred and forty-two (142) days after the \$20.8 billion dollar fine, **my father's funeral was desecrated in the Episcopal Church where he was a Priest**. The plaintiff, Dr. Nancy J. Shaffer, in FD-16-00031 and her attorney, had an insulting letter delivered to me at the beginning of my father's funeral. The letter attempted to extort \$240,000 from me.

My father was dying in January and February of 2016. I could not spend time with him because I had to stay in Pittsburgh to defend myself against the fabricated false charges by Magistrate Ronald Arnoni.

My father, Reverend Dr. Dallas B. Shaffer, did not accept money for his services. He was a hospital chaplain. He was an honorable US Army veteran who served on foreign soil. Notice the 13 tri-fold flag of an honorable US Army veteran by his casket. ATTACK 3: ARNONI'S POLICE OFFICER KACH TRYING TO ENTER MY HOME ALONE, THREATENING TO ARREST ME ON FALSE CHARGES:

On November 21, 2016, Sergeant Kach returned to my home, alone! This was a violation of the “buddy system” policy for Bethel Park and all police officers in the United States. Officer Kach tried to enter my home. I was alone, so instead of letting Officer Kach enter my home where no one could see what he was doing, I walked outside into the sunshine of my driveway where neighbors could see us.

Officer Kach then got his face about inches from mine and started screaming at me and blowing his spittle into my face. Under threat of arrest, Officer Kach ordered me to pay for \$7500 in damages to a neighbor’s car. I refused because I had nothing to do with the damage to my neighbor’s car. I also refused because Officer Kach is not a Judge or Magistrate and thus has no authority to order me to pay anything to anyone. ATTACK 5: THE ILLEGAL RETALIATION AGAINST ME BY MAGISTRATE RONALD ARNONI AND COMMON PLEAS JUDGE HUGH F. MCGOUGH FOR FILING AN EEO COMPLAINT AGAINST NETL CHIEF COUNSEL SUSAN E. MALIE

ON JUNE 11, 2021, I notified the US Department of Energy's Office of Civil Rights that I would be filing an EEO Complaint Against NETL Chief Counsel Susan E. Malie for retaliating against me for my work as a civil rights activist in Pittsburgh when she was the City Solicitor of Pittsburgh.

As a board member of the Thomas Merton Center in Pittsburgh, I had organized peaceful protests and filed lawsuits (e.g., People Against Police Violence v. City of Pittsburgh, US District Court for Western PA, the Honorable US District Court Judge Joy Flowers Conti presiding) against Susan E. Malie as Assistant City Solicitor and later City Solicitor of Pittsburgh.

I cc'd my June 11, 2021 email to NETL Chief Counsel Susan E. Malie and blind copied to my EEO Counselor Orlando Sepulveda from the DOE National Nuclear Security Administration.

ON JUNE 16, 2021, I officially filed my EEO Complaint against NETL Chief Counsel Susan E. Malie for, in 2018, fabricating false charges against me and having my life violently endangered at the NETL while I was a federal employee, ultimately forcing me to flee federal service in July of 2018 to protect my life.

ON JUNE 18, 2021, two days after I filed my EEO Complaint against Malie, the Magistrate of Bethel Park, Ronald Arnoni, summoned me to stand trial in his Court and began charging me \$600/day, ostensibly because he didn't like the way the lawn was being groomed at my house at 2786 Tischler Road in Bethel Park – a house that he and McGough had already stolen from me under color of law and forbid me from returning to.

ON JUNE 28, 2021, Allegheny County common pleas Judge Hugh F. McGough gave power-of-attorney over me to a hostile opposing attorney, Mark B. Morrow.

Below is a copy of the email I sent to the DOE Office of Civil Rights on June 16, 2021. My EEO Complaint was later determined to be timely and proceeded, because the clock starts ticking on the 45-day limit not when the violation happens, but when the victim becomes aware of the violation.



The retaliation by NETL Chief Counsel Susan E. Malie (former City Solicitor of Pittsburgh), Magistrate Ronald Arnoni, and common pleas Judge Hugh F. McGough (former Solicitor for the Pittsburgh Citizens' Police Review Board) was illegal under 42 U.S. Code § 12203 – “Prohibition against retaliation and coercion”, The Whistleblower Protection Act of 1989, 5 U.S.C. 2302(b)(8)-(9) and other laws protecting those filing EEO Complaints and whistleblowers.

Docket FD-16-00031 is purportedly a divorce case in the equitable distribution phase. It was opened on January 8, 2016 by Ronald Arnoni. My wife and I were about the same age. We had no children. We made about the same annual income. According to Allegheny County Solicitor Luke C. Kelly, who is representing my ex-wife Dr. Nancy J. Shaffer, we had about the same amount of retirement savings. I do not believe him.

In any case, we only needed to sell our house and divide the profits in selling our house. That should have taken at most a year. After more than nine years, FD-16-000031 is still open with no end in sight.

If you would like a measure of how vicious, violent, ubiquitous and unrelenting the attacks on me were, below is a copy of my FOIA request to the Office of the General Counsel of the USDOE Sandia National Laboratory. Sandia is one of our nuclear weapons labs.

Dear DOE FOIA Officer Morris,

It seems that NNSA figured out that DOE HQ should handle my FOIA request for the job description of NNSA "EEO Counselor" Orlando Sepulveda. I've cc'd Mre. Sepulveda to give him the opportunity to provide his job description so we can all avoid the headaches of this ordeal.

In 2010, I was on the lead team responding to the most dangerous environmental threat our country has faced, the Deepwater Horizon oil leak. I played an important role in stopping the damage being done to one thousand miles of US shoreline, then in causing British Petroleum to be fined \$20.8 billion dollars. It is the largest single fine of a single entity in the history of our great country. Those funds went to the 50 million people of five Gulf states to recover and rebuild.

For 27 years and 3 months, I safely kept the secret that we gave nuclear weapons technologies to the President of Pakistan Muhammed Mian Nawaz Sharif and A.Q. Khan, the infamous proliferator of nuclear weapons technologies. At that time (1993 - 1998), Muhammed Nawaz Sharif was on the payroll of Osama bin Laden.

On a related matter, as soon as Trump took office in 2017, I was attacked at the USDOE NETL by senior federal employees of the Trump Admin. The attacks were led by Dr. Grace Bochenek, a former Secretary of Energy under Trump. Dr. Bochenek was formerly the Director of the US Army Chemical and Biological Combat Capabilities Development Command. The attacks were in retaliation for causing the \$20.8 billion fine and in the commission of espionage with my US Patent 8,391,552, and in retaliation for my civil rights work in Pittsburgh.

To escape the attacks and to protect the state secrets about nuclear weapons the USDOE had trusted me with, I tried to end my life. I failed.
