Dear Honorable Judges, attorneys and citizens of Pennsylvania serving on the Judicial Conduct Review Board:

This supplemental information is about the most damaging attacks on me after the \$20.8 billion fine was ordered on October 5, 2015, by the Honorable US District Court Judge Carl J. Barbier for the Eastern District of Louisiana. It is obvious to me that the retaliatory attacks by the following were coordinated and collaborative:

DOE NETL Chief Counsel Susan E. Malie	former City Solicitor of Pittsburgh
Common pleas Judge Hugh F. McGough	former Solicitor for the Pittsburgh Citizens' Police Review Board
Magistrate of Bethel Park Ronald Arnoni	of Jonny Gammage infamy

I'm an engineer. I'm not an attorney. That said, it sure looks to me like their attacks were a violation of the Racketeer Influenced and Corrupt Organizations (RICO) Act.

In this document I describe, under penalty of perjury, the attacks done to me by Allegheny County Solicitor Luke C. Kelly and the other "RICO conspirators" starting two days after the massacre of Jewish people in the Tree of Life or L'Simcha synagogue in Pittsburgh on October 27, 2018.

The only people who helped me after I'd fled into Amish country Ohio to escape the attacks by the RICO Conspirators were Distinguished Professor of Bioengineering Dr. Harvey S. Borovetz and Dr. David Israeli, MD, CEO of Magenta Medical in Kadima, Israel.

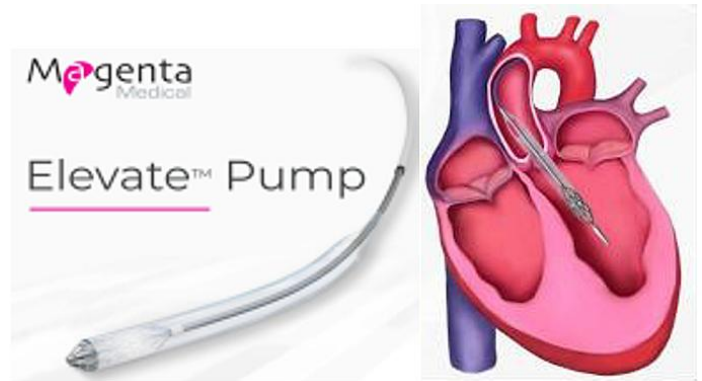

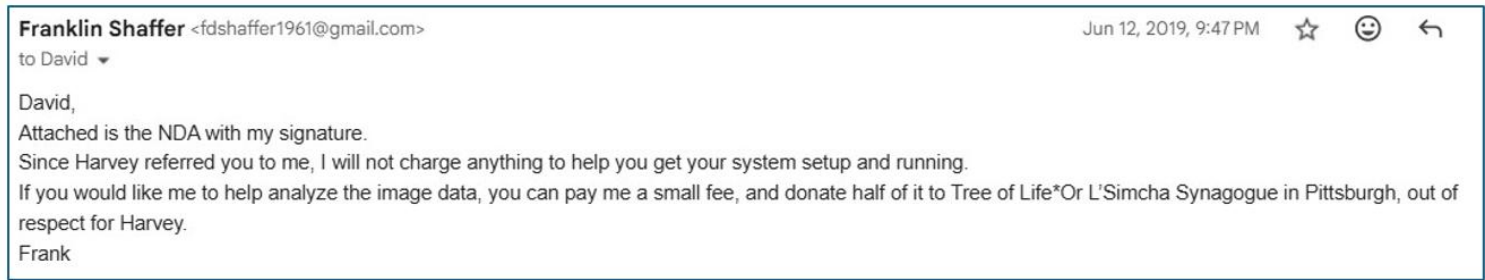

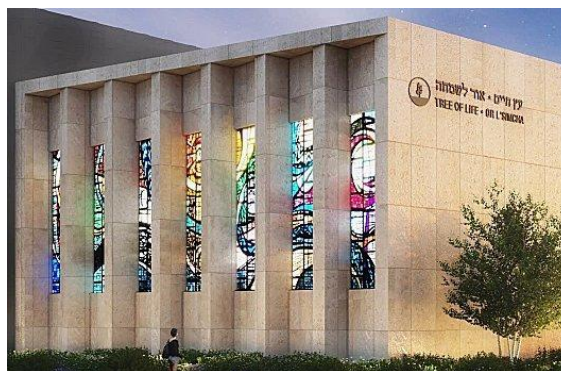

She speaks German, English, Hebrew, and French. Jacqueline grew up in Cologne, Germany and has lived in the U.S. for over 25 years.

Harvey was raised in the Tree of Life synagogue or L'Simcha synagogue (and its predecessors) in Pittsburgh. On the wall of the hallway leading into the old synagogue in the Tree of Life are photos and portraits of the past Rabbis and VIP's of the Tree of Life. On that wall is a photo of Harvey when he received his PhD in Bioengineering from Carnegie Mellon University.

On October 27, 2018, a neo-Nazi named Robert Gregory Bowers walked past Harvey's photo, then slaughtered eleven Jewish people who were simply, peacefully observing a Shabbat morning, critically wounded two others, and then shot five responding Pittsburgh police officers.

THE ATTACKS BY THE RICO CONSPIRATORS IMMEDIATELY AFTER THE MASSACRE AT THE TREE OF LIFE

Allegheny County Solicitor Luke C. Kelly began his Attacks on me in September of 2018. He knew I was married to a German Jew who lost family in the holocaust. I knew we lived near the Tree of Life and attended occasionally.

On October 29, 2018, two days after the worst hate crime against Jewish people in US history, he escalated his attacks on me. He cut me off from the spousal support awarded by Judge Kathryn Hens-Greco then continued to attack me until I tried to end my life April 7, 2019, to escape the attacks by Kelly and the other RICO Conspirators. After I tried to end my life to escape, the RICO Conspirators again escalated their attacks on me.

I believe the actions of Allegheny County Solicitor Luke C. Kelly constitute hate crimes.

THE FAILURE OF NATIONAL NUCLEAR SECURITY ADMINISTRATION EEO COUNSELOR ORLANDO SEPULVEDA TO PROTECT ME FROM THE ATTACKS BY THE RICO CONSPIRATORS

The following is about the NNSA EEO Counselor assigned to me in 2021, Orlanda Sepulveda, when I again tried to file another EEO Complaint against NETL Chief Counsel Susan E. Malie. As you will see in the following, I am not happy with NNSA EEO Counselor Sepulveda, because he did nothing when I informed him that I was attacked by the RICO conspirators. He did nothing while he watched the RICO conspirators continue to attack me.

This is supplemental information in regards to the section of my original Confidential Request for Investigation of Magistrate Arnoni:

ATTACK 5: THE ILLEGAL RETALIATION AGAINST ME BY MAGISTRATE RONALD ARNONI AND COMMON PLEAS JUDGE HUGH F. MCGOUGH FOR FILING AN EEO COMPLAINT AGAINST NETL CHIEF COUNSEL SUSAN E. MALIE

At that time, Attorney Patricia Zarata, Deputy Director of the USDOE Office of Civil Rights was my “Attorney Advisor.” She is one of the best attorneys I’ve met.



Allegheny County Solicitor Luke C. Kelly began his Attacks on me in September of 2018. On October 29, 2018, two days after the worst murder of Jewish people in US history, the massacre at the Tree of Life synagogue in Pittsburgh, he escalated his attacks on me. He cut me off from the spousal support awarded by Judge Kathryn Hens-Greco.

Kelly “triggered” me in the most hateful ways. He knew that in the late 1990’s I was married to Jacqueline Saslawski, a German Jew who lost family in the holocaust. He knew we lived near the Tree of Life. He knew we occasionally attended the Tree of Life. **I believe his heinous actions constitute hate crimes.**

**THE FIRST CRADA BETWEEN THE US DEPARTMENT OF ENERGY
AND AN OUTSIDE ORGANIZATION**

According to the Technology Transfer Officer for the USDOE Pittsburgh Energy Technology Center, Kay Downey, my CRADA with the University of Pittsburgh Schools of Medicine and Engineering was the first CRADA between the USDOE and an outside organization. I mention Kay in my supplemental information I sent to you (by US Postal Mail) about the proliferation into Pakistan.

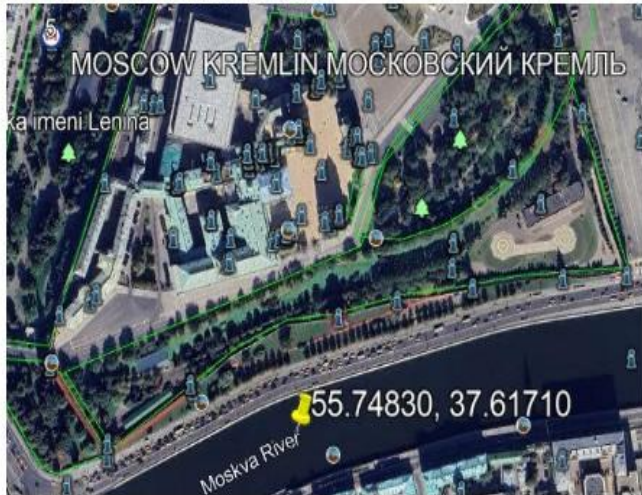

Remember my email of February 10, 2024, titled "Blow up Zion?" A copy is attached.

Two days later the Kremlin visited my website from this IP address: 5.228.155.249

Here's a screenshot of the location:



I can see what visitors to my website look at. The Kremlin didn't stay long. They departed when they saw the photos of my hometown hero Congressman Harley O. Staggers with John F. Kennedy. I guess they're still sore about the Cuban missile crisis.

Orlando Sepulveda and FBI SCV Agent Lisa Brown essentially destroyed my life. I had a prima facie EEO case against NETL Chief Counsel Susan E. Malie for retaliation. When I filed the EEO Complaint, common pleas Judge Hugh F. McGough and Magistrate Ronald Arnoni immediately retaliated. McGough gave power-of-attorney over me to a hostile opposing attorney and Arnoni started charging me \$600/day ostensibly because he didn't like the way the lawn was being mowed at the house they'd stolen from me. Sepulveda watched and did nothing. The criminal McGough is still attacking me.

I would have never said a word about Pakistan. I'd been silent about it for 28 years.

Why didn't you just give me a job? I didn't retire voluntarily. I fled federal service because I was being violently attacked at the NETL.

Sepulveda does not deserve to be a federal employee. He deserves to be an inmate in a federal prison.

Why don't you do the right thing and return me to federal service? Then we can end this mess.

Otherwise, I'm going to start telling my story to your funding sources in the Senate and Congress.

I'll start with Chuck Shumer. See attached letter to Harley O. Staggers Jr from Chuck Shumer. I think that and the Blow up Zion email will get his attention.

I always address anyone in the DOE as "DOE Family." I'm from a small town, Keyser, in West Virginia. My family was close with the family of Congressman Harley O. Staggers Sr (former Chair of the House Committee on Energy and Commerce). He's also from Keyser. In 1977, Congressman Staggers Sr and President Carter founded and funded the United States Department of Energy. The photo below is of First Lady Rosalyn Carter and President Carter with Congressman Staggers Sr and his wife Mary Casey Staggers.



I was an Executive Officer of AFGE 1916 at the Pittsburgh site of the USDOE National Energy Technology Laboratory.

I was also an EEO Counselor. I was the AFGE Building Stewart for Building 84 at the Pittsburgh site of the NETL. That's where NETL Chief Counsel Susan E. Malie had me attacked by Site Security Officer Alan Lichvar and his henchmen. I had to flee federal service to protect my life.

I was on the AFGE team that negotiated our contract with the NETL. It was my job to make sure protections for those who were being discriminated against were built into our contract.

Orlando, you were my NNSA EEO Counselor. When I told you that I was being attacked and my life was in danger, did you notify local law enforcement and ask them to do a wellness check? Did you notify the county Sheriff? Did you notify the FBI? Because I can find no evidence that you did any of those things. I hope I'm wrong.

I've now convinced the Judicial Conduct Review Board of the commonwealth of Pennsylvania to do an investigation of those who've been attacking me under color-of-law for the past nine years. It's attached. Their investigation has been underway since March 6 of this year.
